Topic: New Jersey Lead and Copper Rule Revisions: What We Know and What's to Come

Seminar to discuss the Lead and Copper Rule Revisions (LCRR), published on January 15, 2021 by the Environmental Protection Agency (EPA), and New Jersey Bill A5343, passed by NJ Governor Murphy on July 22, 2021. The effective date of EPA LCRR is December 16, 2021 and compliance with this rule must be met by October 16, 2024. The EPA has until December 16, 2021 to make any additional changes to the LCRR. Once effective, further guidance from individual states is expected. NJ Bill A5343 took effect immediately upon signature. Major changes addressed in both EPA LCRR and NJ Bill A5343 include a full service line inventory, a lead service line replacement program, and increased public outreach.
